### **General Information:**

The Tenth NASA Goddard Conference on Mass Storage Systems and Technologies, in cooperation with the Nineteenth IEEE Symposium on Mass Storage Systems, will host a Vendor Expo April 16-18, 2002 at the Inn and Conference Center, at the University of Maryland University College, in College Park Maryland. The Expo will be held in the Founders, Ft. McHenry, and Chesapeake rooms of the University College Conference Center, directly across from the auditorium.

Once space has been confirmed, the attached registration form should be filled out and mailed or faxed to RS Information Systems. The fee for each 8' by 8' exhibit space, which includes a 3' by 6' table and 2 chairs, is \$500. In addition, all vendor participants must register at a cost of \$500 per person. Vendor participants will have full access to all refreshments, lunches, receptions, and the banquet dinner. Payments must be received by Jan 31, 2002.

The Conference will also host a Vendor Interoperability Demo, on Thursday, April 18, 2002, 1:30 p.m. 3:30 p.m. Vendors interested in signing up for 30 minute presentations during the Interoperability Demo should send a brief description of the planned demo to Ben Kobler (kobler@gsfc.nasa.gov) no later than January 31, 2002. Vendors may, at their option, contact one of the NASA Goddard SEWP storage integrators to help coordinate and facilitate the interoperability demo (information on SEWP is available at: http://www.sewp.nasa.gov). The proposed demo should include, in addition to the SEWP storage integrator, at least 2 conference participating booth vendors, and should demonstrate storage interoperability between participating booths over a high-speed storage network.

GES Exposition Services will handle logistics for shipping and setup and will be in touch to finalize arrangements. There will be additional costs for electrical, phone, and network connections. Arrangements for these additional items should also be made directly with GES Exposition Services.


