### Abstract

These are the instructions to authors for preparing their manuscripts for publication in the Proceedings of MSST2004, the 12th NASA Goddard / 21st IEEE Conference on Mass Storage Systems and Technologies.

## 1. Title

The title of the paper should appear centered on the first page in 14 point upper case, **bold** Times font.

## 2. Author(s)

The author name(s) should appear centered one space underneath the title in 12 point **bold** Times font.

## **3. Organization(s)**

The name of the business affiliation(s), mail stop, city, state, zip code, country if outside the USA, e-mail address, telephone number, and fax number, should follow, centered underneath the author(s) in 12 point non-boldface Times font. If there is more than one author, each author's information should be centered separately. The format for US, and Canadian phone, numbers is: +1-800-123-4567. Foreign authors should use a similar format, inserting their own country code, instead of 1, after the "+".

## 4. Type Style and Type of Text

Text is to be formatted single space in 12 point Times font single column format. All paragraphs should be blocked (no indentation) with even right margins. There should be a blank line between paragraphs and between figure captions and text. Do not use exotic fonts, or characters special to particular languages unless you can *embed* the fonts. Some licenses may not permit the embedding of special fonts.

## 5. Document Size

The document will not be reduced in size prior to printing, but will be printed at 100% of the original size. Page size is 8  $1/2 \times 11$  inches (standard US letter size). Left and right

margins must be 1.25 inches; top and bottom margins must be 1.00 inches. *International authors: please ensure that your document conforms to American page size, not the A4 page size.* 

## 6. References

List and number all bibliographical references in order of citation at the end of the paper. When referring to them in the text, type the corresponding reference number as follows: [1] for reference 1.

## 6.1. A Subsection

## 7. Footnotes

Avoid them unless they are essential.

## 8. Page Numbers

Place centered page numbers at the bottom. The first page should be numbered 101. Publications will replace these with the correct page numbers for the final proceedings.

## 9. Format

Manuscripts should be submitted in Adobe Portable Document Format (PDF).

## **10. Sample Paper**

A sample paper in PDF [1] and one in LaTeX [2] are available for download.

# **Author Guidelines for MSS Symposium Proceedings**

### Abstract

The abstract is to be in fully-justified italicized text, at the top of the left-hand column, below the author and affiliation information. Use the word "Abstract" as the title, in 12-point Times, boldface type, centered relative to the column, initially capitalized. The abstract is to be in 10-point, single-spaced type. The abstract may be up to 3 inches (7.62 cm) long. Leave two blank lines after the Abstract, then begin the main text.

### 1. Introduction

Please follow the steps outlined below when submitting your manuscript to the publications chairs.

### 2. Instructions

Please read the following instructions carefully. You may use this LATEX document as a template if you're using LATEX to prepare your document. There is also a Microsoft Word template if you prefer. However, you may use any word processor you like, as long as you follow the guidelines listed here. Note that all manuscripts must be in English.

### 2.1. Acceptable formats

Your paper *must* be submitted electronically. The only acceptable formats for your final paper are PDF (preferred) or PostScript. PostScript in particular can be finicky; if your PostScript doesn't convert to PDF at our site, we will ask you to provide PDF directly.

### 2.2. Margins and page numbering

All printed material, including text, illustrations, and charts, must be kept within a print area 6-7/8 inches (17.5 cm) wide by 8-7/8 inches (22.54 cm) high. While

many conferences require that you omit page numbers, MSST 2004 requires that your paper have page numbers starting at 101 centered at the bottom of each page including the first.

### 2.3. Formatting your paper

All text must be in a two-column format. The total allowable width of the text area is 6-7/8 inches (17.46 cm) wide by 8-7/8 inches (22.54 cm) high. Columns are to be 3-1/4 inches (8.25 cm) wide, with a 3/8 inch (0.95 cm) space between them. The main title (on the first page) should begin 1-3/8 inch (3.49 cm) from the top edge of the page. The second and following pages should begin 1.0 inch (2.54 cm) from the top edge. On all pages, the bottom margin should be 1-1/8 inches (2.86 cm) from the bottom edge of the page for  $8.5 \times 11$ -inch paper; for A4 paper, approximately 1-5/8 inches (4.13 cm) from the bottom edge of the page.

### 2.4. Type-style and fonts

Wherever Times is specified, Times Roman may also be used. If neither is available on your word processor, please use the font closest in appearance to Times that you have access to. If possible, use only Times, Helvetica, Courier, Symbol, and Dingbats fonts in your paper. Any other fonts must be embedded in your document to ensure that it will print properly. LATEX users: you *must* use the times package; the Computer Modern Roman font produces poor PostScript.

### 2.5. Main title

Center the title 1-3/8 inches (3.49 cm) from the top edge of the first page. The title should be in Times 14-point, boldface type. Capitalize the first letter of nouns, pronouns, verbs, adjectives, and adverbs; do not capitalize articles, coordinate conjunctions, or prepositions (unless the title begins with such a word). Leave two blank lines after the title.

### 2.6. Author names and affiliations

Author names are to be centered beneath the title and printed in Times 12-point, non-boldface type. Affiliations and email addresses are to be below each author's name, and set in Times 12-point italic type. If all authors have the same affiliation, the affiliation can appear centered below all authors' names. This information is to be followed by two blank lines.

### 2.7. Paper body

The body of the paper (including the abstract) must be in a two-column format.

The main text should be set in 10-point Times, singlespaced. All paragraphs should be indented 1 pica (approx. 1/6 inch or 0.422 cm). Make sure your text is fully justified—that is, flush left and flush right. Please do not place any additional blank lines between paragraphs.

### 2.8. Figures and tables




Figure 1. How to figure it out.

Figure and table captions should be 10-point Helvetica boldface type as shown in Figures 1 and 2. Short captions (single line) should be centered, as in Figure 1. Long captions should be aligned on both sides and indented 1 pica on both left and right, as demonstrated in Figure 2. Figure captions should be below their figures, while table captions should be *above* the table, as shown in Table 1.

Figures and tables must be centered, and should be placed in a single column if possible; however, large figures and tables may span the entire page if necessary. Pagespanning figures and tables should be at the top or bottom of the page. Figures and tables *must* be included as part of the PostScript or PDF document—no cut and paste!

We will be printing the proceedings in black and white. However, color in your document is acceptable as long as the black and white version is still readable and comprehensible; the CD-ROM will allow readers to see color figures.

### 3. First order headings

First-order headings should be Times 12-point boldface, flush left, with one blank line before, and one blank line after. Only the first word of first-, second-, and third-order headings should be capitalized. All numbers in the section number should be followed by periods.

### 3.1. Second order headings

Second order headings should be Times 11-point boldface, flush left, with one blank line before, and one after.

**3.1.1. Third order headings.** If you require a thirdorder heading (we discourage it), use 10-point Times, boldface, flush left, preceded by one blank line, followed by a period and your text on the same line.

### 3.2. Footnotes

Please use footnotes sparingly<sup>1</sup>; instead, include necessary peripheral observations in the text (within parentheses, if you prefer).

### 3.3. References

List and number all bibliographical references in 9-point Times, single-spaced, at the end of your paper. When referenced in the text, enclose the citation number in square brackets, for example [1]. Multiple citations [1, 2] should be in a single set of square brackets.

### 3.4. Copyright forms

You must include your signed IEEE copyright release form when you submit your finished paper. We *must* have this form before your paper can be published in the proceedings.


